AMENDMENT TO WORK/FINANCIAL COOPERATIVE AGREEMENT (FY21) between State of Idaho Wolf Depredation Control Board and Idaho Department of Fish and Game

IDFG and the WDCB (collectively the Agencies) amend the FY21 Work/Financial Cooperative Agreement, dated June 23, 2020, as follows:

Reason for Amendment:

Winter conditions through early February were not favorable for aerial-based wolf removal in central Idaho, and there will be limited availability of qualified contractors for helicopter-based services for the remainder of the winter. As a result of these circumstances, IDFG anticipates that under its current work plans, it would have at least \$30,000 in unexpended funds at the end of FY21.

Plan of Action:

In FY21 IDFG's services to the WDCB are amended to include providing nonprofit organization grant funding for reimbursement of hunters and trappers for expenses incurred during the process of legal wolf harvest in certain game management units identified by IDFG to support wolf management objectives. To provide these services, IDFG will amend its Cooperative Agreement, dated September 9, 2020 with the Foundation For Wildlife Management (F4WM) to increase, by a total of thirty thousand dollars (\$30,000), the amount awarded for F4WM's applications for 2020 Commission Community Challenge Grant requests, with all other provisions and terms of this Cooperative Agreement remaining in effect, including but not limited to identification of regional priority areas (by game management unit), matching funding, reporting requirements, and schedule.

IDFG's provision of the services in the above paragraph is subject to: (1) consistency with Idaho Fish and Game Commission direction to the WDCB for expenditure of funds, as may be modified, and (2) the Commission's approval of an increase in funding to the Commission Community Challenge grant program and to the individual grant award, based on F4WM's previously submitted applications.

OBJECTIVES/GOALS and COST ESTIMATE for Services:

The Objectives/Goals and Cost Estimate provisions of the FY21 agreement are amended to authorize reimbursement of costs incurred by IDFG for the services as amended above, with the total funds available to IDFG remaining at \$110,000. The table of estimated itemization of expenses is amended to reflect that IDFG may exchange up to \$30,000 funds originally estimated in other categories to increase the 2020 Commission Community Challenge Grant program as described above.
